ABOUT THIS ROLE

Job Title: Lighting Technician Line Manager: Head of Lighting

MAIN PURPOSE

Working within a department of four, the Lighting Technician assists the Head of Lighting and Deputy Head of Lighting with all aspects of lighting for productions in both theatre spaces at the Royal Court, throughout the building and with projects in other locations.

The Lighting Department is one of four Production departments at the Royal Court – the others are Stage, Sound and Costume.

RESPONSIBILITIES Lighting and Production

- Working on production fit ups and get outs as determined by the Head of Lighting in both the Jerwood Theatre Downstairs and the Jerwood Theatre Upstairs.
- To act as lighting supervisor on productions in the Jerwood Theatre Upstairs and the Jerwood Theatre Downstairs with support from the Head and Deputy Head of Lighting.

- The ability to program on ETC Eos range of consoles where applicable.
- Operating lighting and/ or video for shows in the Jerwood Theatre Downstairs.
- Maintenance of lighting equipment including PAT testing.
- Undertaking rigging and focusing of lighting and occasionally video.
- Acting as the duty electrician during performances in the two theatres.
- Reading and interpreting lighting plans.
- Working alongside and assisting with the supervision of casual staff as required.
- Liaising with visiting companies and co-producers regarding lighting issues, as required.
- Undertaking maintenance of lighting throughout the building (including Front of House areas) as determined by the Head of Lighting, including annual inspections.
- Carrying out any other duties required by the theatre in pursuance of the above objectives.

General

- Attending company, production and departmental meetings as required.
- Attending Royal Court productions, readings and other events when required.
- Contributing to a respectful and inspirational working culture at the Royal Court, including in relation to sustainability, health and safety, safeguarding and other policies; and upholding and developing our commitments and practice around anti-racism and anti-oppression.
- Attending training forums and wider organisation meetings as appropriate to feed into and collaborate on the delivery of all our work.

This job description is a guide to the nature of the work required of a Lighting Technician. The postholder may be required to undertake other duties appropriate to the nature of the post as agreed with the Head of Lighting and Deputy Head of Lighting.

PERSON SPECIFICATION

Knowledge and Experience

- Experience of operating ETC lighting consoles.
- Previous theatre experience, including a general knowledge of electrical maintenance and PAT testing.
- Experience working with lighting designers and other creative teams.
- Experience and skilled use of Microsoft Office, Vectorworks and Lightwright.
- Some knowledge and experience of video projection and control systems.
- Harness training and IPAF licensing is desirable, though full training will be provided.

Abilities/Skills

- Ability to respond to problems creatively, calmly and positively.
- An open and flexible approach, willingness to learn and develop new skills.
- Excellent team worker with the ability to work to deadlines.

Hours: 40 hours per week, scheduled over 5 days Monday to Saturday.

Minimum call 8 hours. Due to the nature of this role evening and week end work will be required and you may be asked to work additional hours on a regular basis and some overtime will be expected during busy periods. You have the right to opt out of planned overtime.
